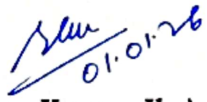

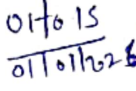

4. The in-situ posting of the above mentioned Officers shall remain effective until further orders.

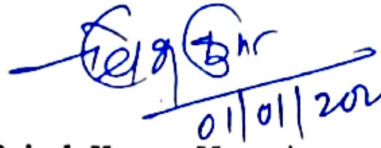
